## **CALL TO ORDER**

They would like all the signs to be monument design, conforming in size and color. President Merrill stated he would like Beach Walker to have their own logo. James Thompson moved to spend up to \$5,000 for a stucco monument sign to be installed. Wayne Middleton seconded the motion. The vote passed unanimously.

### **NEW BUSINESS**

Mr. Thompson spoke about insurance coverage. He stated the pool walkways, bath house, and boardwalks may not have appropriate coverage. If a severe storm was to hit there would be a great loss with no money to replace the items. A brief conversation ensued.

Joann Speas spoke to the Board regarding the resent decision to close the first floor trash shoots on C building. She stated the chute was used by the entire first residential level of the condominium. She also feels strongly the renters will not go the second floor to empty garbage. The Board decided to wait until the next meeting to see if any ill effects have taken place due to the decision.
